## President's Corner



Look who is standing and learning to walk! It's been a long haul but I see the light at the end of the tunnel. I hope I will be walking unassisted when you see me at April's community meeting.

Thank you to the volunteers who signed up for pool duty. I am thrilled that we have some new people volunteering this year. Please don't forget that if you can't commit to a 2-hour shift once a week I will happily take your name to be a substitute to fill in for a monitor that can't make a shift. I would love if you let me know that you are willing to be a sub before the pool opens so you can attend the monitor training. The pool schedule is posted in this press so you can see I only have a few shifts left open! I would like to give a shout out to Mindy Ryan who helped Joe with removing chairs and lounges from the pool bathrooms so we can get the water turned on. I appreciated her filling in for me. The pool will be open Saturday, May 24<sup>th</sup> for Memorial Day weekend. If you need pool badges, please contact me.

How is everyone enjoying our new water cooler? I hope we will have a lot less waste and we are doing our part to help the environment with using less plastic. Please feel free to fill your own water bottle or mug but do not use the cooler to fill up coffee pots as the water is boiled and there is no need for us to pay for water for coffee pots. Just a reminder that all alcoholic beverages need to be under lock and key. The board donated the mini fridge we used for

water bottles to the men's club as long as they put a lock on the door to store their beer. The lock they put on did not work but I understand they are going to fix it. There is a lock on a cabinet in the kitchen to store wine and other alcoholic beverages. All alcohol must be locked up when the clubhouse is not occupied. The board is enforcing this rule as it is a liability so, please be mindful and not leave alcohol out.

Now a new but old problem. STOP FEEDING THE WILDLIFE! First, they are wild animals which means they know how to take care of themselves without any assistance from humans. I know people think they are helping them and being kind, but that is not the case. Throw your stale bread out or make bread crumbs or croutons. Bread is not good for geese or deer. It causes them to be malnourished and susceptible to disease. It also makes them congregate together, which spreads saliva and feces and ticks. What effects them can be transferred to us. Feeding wildlife also upsets the natural ecosystem. Food you throw in the lake rots when not eaten and causes water pollution and algae which harms the fish and other wildlife depending on the lakes. Let's face it, the poop all over the grove and our lawns is not pleasant. Debbie Polizzano has worked very hard planting shrubs and flowers and the geese and deer are wreaking havoc by eating the plants and leaving feces everywhere. She is tired of shoveling up poop and I don't blame her. I'm tempted to have the people who insist on feeding them do the cleanup for her. In case you are not aware Stafford has an ordinance stating that you are not allowed to feed wild animals and will be fined if you are caught. Ok I am done preaching, but please take this seriously and stop feeding the wildlife and let us co-exist naturally and not destroy the delicate balance that God created among us.

## Fawn Lakes Pool Rules 2025

1. There is no entrance to pool without a pool badge. Wristbands for additional guests may be purchased for \$2.00
2. Guests are not allowed without the resident. All members and guests must sign in at the pool monitor station.
3. The pool will be open Memorial Day weekend until the week after Labor Day at the discretion of the Pool Director.
4. Pool hours will be 10:00am- 6:00pm. Friday and Saturday the pool will be open 10:00am to 8:00pm. If no one is using the pool, or a monitor is not available, the pool will be closed at our discretion.
5. You must shower each time you enter the pool, especially after applying sun screen.
6. Bathing suits and swim trunks only. No street clothes allowed in the pool.
7. Children are permitted in the pool as long as they are accompanied by a resident.
8. If a child is not potty trained, a swim diaper is mandatory.
9. Children who cannot swim, must stay in the shallow end and not proceed past the rope. They must be accompanied by an adult who is responsible for their supervision and safety.
10. Small pool toys are allowed as long as they do not interfere with others.
11. Diving, running and running jumps into water are prohibited.
12. No glass of any kind is allowed inside the pool area.
13. No smoking, vaping or chewing tobacco is allowed inside the gated area of the pool.
14. Pool safety equipment (painted red triangle on both sides of pool), must remain accessible at all times.
15. Long hair must be tied back.
16. Pool director, pool manager, and pool monitors are not lifeguards. You are responsible for you, your children, and your guest's safety.
17. No one is allowed in pump house except the pool director and pool manager.
18. Everyone who works at the pool are VOLUNTEERS. Rude behavior or arguments with staff will not be tolerated. Check your attitude at the door.

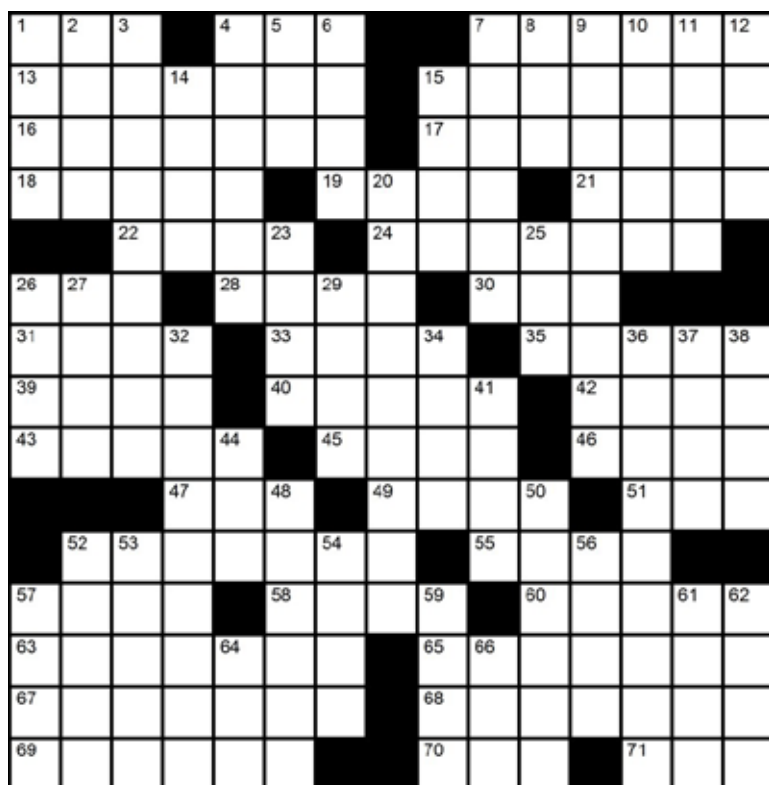

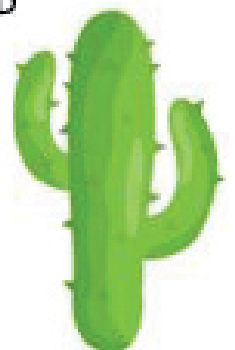

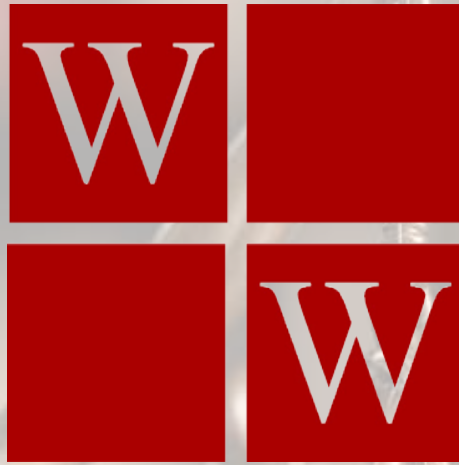
