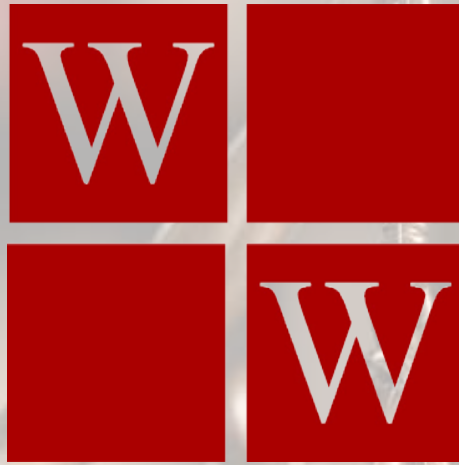

Condo I

The Board of Trustees of Condo One wish all the residents in Fawn Lakes a wonderful holiday season. May your Christmas, Hanukkah, Kwanzaa and New Year be filled with joy and peace. If you are traveling, be safe and aware of your surroundings!!

Our new G-mail account seems to be working quite well for communicating to our residents. If you have not given us your email, please do so by emailing fawnlakescondoal@gmail.com. It is important that we are able to communicate with all of our 206 households.

As of January 1st we will be enforcing late fees for delinquent HOA payments. Payments are due by the 10th of the month. There will be a \$50. fine for late paying residents.

We are working on our Reserve Study as required by the State. Also it's budget time, so we will be presenting our next year's numbers at our December meeting. Last month we had a quite in depth discussion regarding the possibility of an HOA increase. This is still under consideration. As we all know we have not had an increase for 5 years and we are doing our best to keep our expenses down.

Please do not put bulk items (or trash) to the curb prior to the last full week of the month. It is not fair to your neighbors and the community to have the bulk sitting at the curb for weeks. We will be fining homeowners that do not abide by the rules.

If a Condo One resident is planning any work to be done to their unit, either inside or out, a drawing will need to be submitted along with contractor's information, proof of insurance and workman's comp for their contractor's work-

ers. Also the work personnel will need to be listed and given to the Condo One Board of Trustees. This written information can be given to a Trustee for the Board to reviewed. This will need to be presented prior to any work being done in a Condo One residence. **BEFORE ANY CONTRACTOR ENTERS A PROPERTY'S CRAWLSPACE THEY NEED AUTHORIZATION FROM THE BOARD. If a resident has work done without authorization from the HOA, the HOA is not responsible for reimbursement to any unauthorized contractor.**

All owners and or family must notify a member of the Board of Trustees before selling or vacating their units. Violating this notification can jeopardize the sale of your property. Be sure your Realtor is knowledgeable of what the fees and capital donation requirements are. Should you have any questions regarding your sale contact a member of the Board of Trustees.

We look forward to seeing you all at our December 6th meeting at 10 AM meeting; come early for coffee and conversation. The coffee's ready by 9:45 AM!

Any exterior work on the outside of the condo and surrounding area needs to be documented and submitted to the Condo A-3 Association for approval. The homeowner is responsible and liable for interior work/modifications. Check with Stafford Township for permit requirements.

We encourage proper exterior management of your residence (e.g. power washing, gutter cleaning, deck

maintenance, etc.) These items are the responsibility of the resident and could lead to costly repairs if not maintained. If you have planting around your condo, you must maintain the area, which includes removing weeds and trimming bushes. Bushes touching the condo create an entryway for ants and termites.

Are you eligible for a reduction in your electric and/or gas bills??

If you heat with electricity, Atlantic City Electric has a Home Weatherization Program thru New Jersey's Clean Energy Program. If you heat with natural gas, the program is called Save Green Project.

They work jointly to save you energy and money. They are sponsored by NJ electric and gas utilities and are designed to help income-eligible households reduce energy costs and promote the wise use of energy. Program elements include personalized customer education and in many cases, direct installation of proven energy-efficiency measures (ie: insulation in your attic, in the crawl space, caulking around windows, weather stripping around outside doors, and much more and in some cases a new refrigerator thru the electric company's program).

FAWN LAKES CODE OF CONDUCT

We ask all residents of Fawn Lakes to make our community a welcoming and respectful place to live. As such, we expect our residents and their guests to treat other with respect and to abide by the rules in our Code of Conduct at all times.

If a resident experiences or witnesses unacceptable behavior, it should be brought to the attention of a Fawn Lake's officer or Director responsible for handling that issue. If any unacceptable behavior occurs in the pool area or at an event in the clubhouse, it should be reported to the person in charge. Residents are totally responsible for the behavior of their guests.

PROHIBITED ACTIONS:

1. Verbal abuse including insults, derogatory name calling and foul language
2. Aggressive or threatening behavior
3. Hostile touching or physical contact
4. Sexual harassment
5. Defacing, damaging or destroying any condo property or the property of other residents
6. Non-compliance with rules posted in the pool area, clubhouse and common grounds

If a resident is asked to stop displaying inappropriate behavior, immediate compliance will be expected.

CONSEQUENCES:

1. 911 will be called if behavior is deemed to be dangerous to others or to the person exhibiting the dangerous behavior or refusal to leave the area at the time an event is finished.
2. Written warning will be given to the offender by the Board of Directors, for the **first** offense.
3. A **second** offense within a **six-month** period of time will result in a **three-month** loss of privileges to the clubhouse pool, or area where the offense has occurred. A meeting with the community board will be required before privileges are restored.
4. No refunds will be given if a resident or their guest is removed from an event due to non-compliance with Code of Conduct Rules.

Fawn Lakes is a volunteer community where residents give hours of time to maintain services, lower costs, and to provide a safe environment for fellow residents. Please help us continue this tradition.

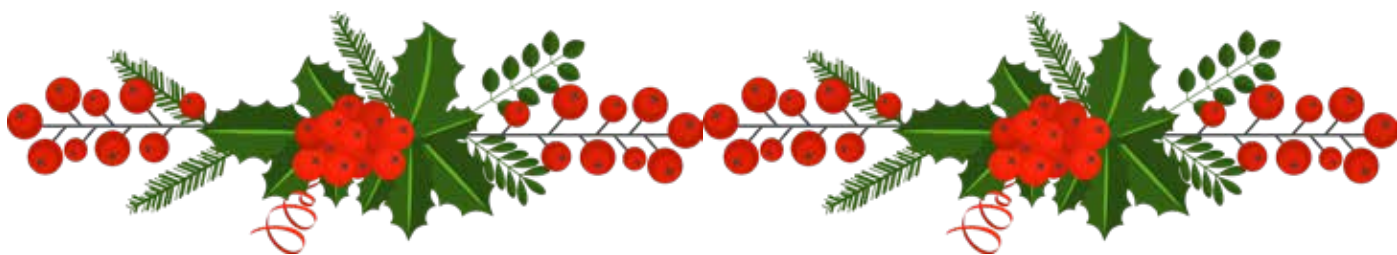

KIRMS PHOTOGRAPHY Holiday Images

It's time to prepare for the holidays - Christmas, Hanukkah, and New Years. The main subjects are family and friends. I run this article every December because I think this is a good time for a review.

For candid shots make certain you're prepared -- have your camera ready and watch the subject for the expression you want. If you aren't ready the shot will be gone before you press the shutter. Most holiday shots will be taken indoors so don't forget to use your camera's flash.

For portraits and group shots get yourself set up first, and then prepare your subject. If you keep them waiting you will not get a natural relaxed image. For portraits choose a background that's festive, but not too busy. Have your subject(s) turn their shoulders slightly so they are not too square to the camera.

When photographing grandchildren or pets try to get eye level with them, rather than shooting down at them.

I also like to photograph the festive holiday decorations. These often make fun shots and they can be used on your holiday cards next year.

Don't forget the rule of thirds (also from a previous photo tip). Rather than placing your subjects in front of the

Christmas tree, move them slightly to one side. If shooting the dinner table set for the holiday feast, have the host stand at one side of the table about 1/3 of the way from the end, rather than centered at the end of the table.

These techniques will help improve your holiday images. Have a great holiday season, a happy and healthy New Year and remember to have fun with your camera.
